2.1 Project Summary

The International Dispute Resolution Conference 2019 ("Conference") aims at fostering discussion on emerging trends in dispute resolution and the impact of the "Convention on International Settlement Agreements Resulting from Mediation" on international business environment. More than 25 world renowned practitioners, academics and senior government officials were invited to share their insights on various important topical issues. The Conference brought together over 850 professionals from dispute resolution, legal, surveying, construction and intellectual property sectors to facilitate the exchange of ideas on the settlement of international disputes and development of the Mediation Convention.

The International Dispute Resolution Conference 2019: New Era of Global Collaboration (IDRC 2019) was a success in many senses; the unprecedented level of participation and positive feedbacks from the participating guests, academics, fellow dispute resolution practitioners, and other professionals were all

unfailing proof of the conference's positive impacts.

With over thirty overseas, Mainland and local supporting organisations, as well as its line-up of international speakers, IDRC 2019 aggregated hundreds of dispute resolution practitioners and experts sharing the same passion for academic and professional exchanges from all over the world. Such organisations included domestic and overseas mediation/arbitration centres (e.g. Thailand Arbitration Center, Japan International Mediation Centre, Shanghai International Arbitration Center), chambers of commerce (e.g. International Chamber of Commerce, the Chinese General Chamber of Commerce Hong Kong), professional bodies (e.g. Hong Kong Bar Association, Shenzhen Lawyers Association), and universities (e.g. the University of Hong Kong, City University of Hong Kong, RMIT University). Given the global constitution of the conference, it was best for the promotion of Hong Kong's dispute resolution services to an audience with different nationalities and professional backgrounds.

The conference served as a perfect occasion not only for promotion but also professional exchanges. The topics of the speeches given by leading scholars and practitioners were meticulously curated with the view to best facilitating the audience's understanding of the latest developments in international dispute resolution; as a case in point, 'International Commercial Mediation 2019, Challenges and Opportunities'. Throughout the conference, the audience was provided with invaluable insights originated from overseas experiences of our guest speakers, which would in turn incentivise local practitioners to perfect the dispute resolution profession in Hong Kong.

In order to help Hong Kong's practitioners keep up with the higher standard in international dispute resolution arising from the ratification of the United Nations Convention on International Settlement Agreements Resulting from Mediation ('Singapore Mediation Convention'), speeches on this specific topic were conveyed by representatives of United Nations Commission on International Trade Law (UNCITRAL) and other leading scholars. That was an indispensable opportunity for the audience to gain first-hand information about the prospective implementation of this pivotal new Convention in different contexts – national, regional, and international. In this regard, it is anticipated that the insights from the conference could bring about localised adaptation of the convention in Hong Kong, on top of a betterment among local dispute resolution practitioners.

3.5 Overall achievements of the project

HKMC has played host to the city's first International Dispute Resolution Conference 2019 – a vital global summit co-hosted alongside the UNCITRAL, the IDRRMI, and in collaboration with the DoJ.

The conference was attended by over 850 delegates from all over the world with positive and encouraging responses. They could learn more about the emerging risks, trends and solutions for commercial, trading and investment disputes among states, organisations, businesses and individuals. More than 25 international and regional dispute resolution experts, practitioners, academics, judges and senior government officials delivered presentations and participated in panel discussion of the conference.

In the face of growing instability and potentially disruptive disputes, the United Nations recently approved the Convention on International Settlement Agreements Resulting from Mediation, a global framework for conflict resolution between international and cross-border parties. This global standard has opened up a wealth of new professional and business opportunities in the dispute resolution field. As a global hub for trade and finance, Hong Kong's integral role in meeting this growing need was spelled out repeatedly at the first International Dispute Resolution Conference 2019.

We believed international dispute resolution is of great importance, in particular for the Belt & Road Initiative and the Guangdong-Hong Kong-Macao Greater Bay Area Development. We will continue our effort in promoting Hong Kong's position as a leading international dispute resolution center in Asia-Pacific region by organising a similar conference in the future.
